

I, **Nikhil Jain, CEO of M/s Ramprastha Promoters and Developers Pvt. Ltd.** do hereby solemnly declare, undertake and state as under:

1. A legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
2. That the time period within which the project shall be completed by M/s Ramprastha Promoters and Developers Pvt. Ltd. is as per records.
3. That seventy per cent of the amounts realised for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

7. That M/s Ramprastha Promoters and Developers Pvt. Ltd. shall take all the pending approvals on time, from the competent authorities.
8. That M/s Ramprastha Promoters and Developers Pvt. Ltd. Have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.


