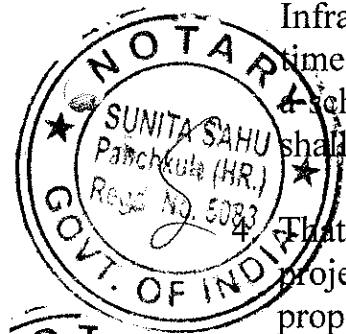
That the time period within which the project shall be completed by M/s Athena Infrastructure Limited is 30 September, 2018.

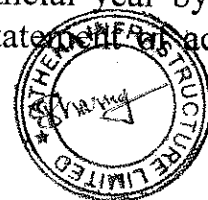

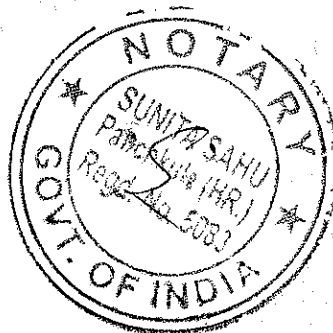
