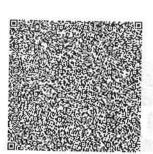

I, Lalit Kumar Aggarwal, Director of M/s SIGNATUREGLOBAL DEVELOPERS PRIVATE LIMITED do hereby solemnly declare, undertake and state as under:

- 1. That M/s SIGNATUREGLOBAL DEVELOPERS PRIVATE LIMITED, has a legal title to the land on which the development of the project is carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith as "Annexure-E"
- 2. That the company has given as collateral security, the land and building mention above in favour of Yes Bank Limited for credit/ Bank Guarantee facility of Rs. 43,90,00,000/availed by the company and cross collateralization on the said land and building for group company's project in favour of Yes Bank Limited for credit/ Bank Guarantee facility of Rs. 55,90,00,000/- availed by group company. The details of any rights, title, interest, dues, litigation and name of any party in or over such land has been attached as "Annexure-F".
- 3. That the time period within which the project shall be completed by promoter is 4 years.
- 4. That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose or as define under THE REAL ESTATE (REGULATION AND DEVELOPMENT) ACT, 2016 guidelines.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project or as define under THE REAL ESTATE (REGULATION AND DEVELOPMENT) ACT, 2016 guidelines.
- 6. That the amounts from the separate account shall be withdrawn [me/ the promoter] after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for a particular project and the withdrawal has been in compliance with the proportion to the project.

- 8. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made there under.
- 10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
