

- Î. That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose or as define under THE REAL ESTATE (REGULATION AND DEVELOPMENT) ACT, 2016 guidelines.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project or as define under THE REAL ESTATE (REGULATION AND DEVELOPMENT) ACT, 2016 guidelines.
