Subject: - **Letter of Intent for grant of license for setting up of Commercial Colony on the land measuring 2.38125 acres in the revenue estate of village Daultabad, Sector 103, Distt. Gurgaon.**

Ref: - Your application dated 06.02.2014.

2. Your request for the grant of license under section 3 of the Haryana Development and Regulation of Urban Areas Act, 1975 and the Haryana Development and Regulation of Urban Areas Rules, 1976 (Rules 1976) framed thereunder for the development of a COMMERCIAL COLONY on the land measuring 2.38125 acres (schedule of land enclosed) in the revenue estate of village Daultabad, Sector 103, Gurgaon Manesar Urban Complex has been examined/considered by the Department and it is proposed to grant license to you. You are, therefore, called upon to fulfill the following requirements/pre-requisites laid down in Rule 11 of the Haryana Development and Regulation of Urban Areas Rules, 1976 within a period of 60 days from the date of issuance of this notice, failing which the grant of license shall be refused.

3. To furnish the bank guarantee on account of Internal Development Charges & External Development Charges for the amount calculated as under:-

A. INTERNAL DEVELOPMENT WORKS (IDW)

A)	Total Area	= 2.38125 acres
B)	Interim rate of Development	= ₹ 50.00 Lacs per acres
C)	Total cost of Development	= ₹ 119.0625 Lacs
D)	25% bank guarantee required (valid for 5 years)	= ₹ 29.76562 Lacs

B. EXTERNAL DEVELOPMENT CHARGES (EDC)

A)	Total Commercial Area	= 2.38125 acres
B)	Interim rate of EDC	= ₹ 441.9404 Lacs per acre
C)	Amount	= ₹ 1052.37057 Lacs
D)	25% bank guarantee required (valid for 5 years)	= ₹ 263.09264 Lacs

4. To execute two agreements i.e. LC-IV & LC-IV-A prescribed under Rules 1976 on Non-Judicial Stamp Paper of ₹ 10/-. Two copies of specimen of the said agreements are enclosed herewith for necessary action.

5. To deposit an amount of ₹ 1,41,66,271/- on account of conversion charges & an amount of ₹ 6,48,89,062/- on account of balance license fees through bank draft in favour of Director, Town & Country Planning, Haryana, at Chandigarh.

(Note: The above demanded fees and charges are subject to audit and reconciliation of accounts).

6. To furnish an undertaking on non-judicial stamp paper of ₹ 10/- to the following effect:-

- I. You shall deposit an amount of ₹ 1,68,64,608/- on account of Infrastructure Development Charges @ ₹ 625/- per sq m for GH area (175 FAR) and ₹ 1000/- per sq m for Commercial Component (150 FAR) in two equal installments after grant of license. First installment shall be payable within 60 days and second installment within six months from the date of grant of license, failing which 18% interest PA will be charged.
- II. You shall pay proportionate EDC as per schedule prescribed by the Director.
- III. You shall submit the additional bank guarantee, if any required at the time of approval of Service Plans/Estimate. With an increase in the cost of construction and increase in the number of facilities in Layout Plan, you would be required to furnish an additional bank guarantee within 30 days on demand. It is made clear that bank guarantee of Internal Development Works/EDC has been worked out on the interim rates.
- IV. You shall maintain and upkeep all roads open spaces, public parks and public health services for a period of five years from the date of issue to the completion certificate unless earlier relieved of this responsibility and thereupon to transfer all such roads / service roads, open spaces, public parks and public health services free of cost to the Government or the local authority, as the case may be, in accordable with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.
- V. You shall deposit thirty per centum of the amount realised, from time to time, by you, from the plot holders within a period of ten days of its realization in a separate account to be maintained in a scheduled bank. This amount shall only be utilized by you towards meeting the cost of internal development works in the colony.
- VI. You shall submit NOC from the Ministry of Environment & Forest, Govt. of India with respect to their notification dated 14.09.2006 and clearance regarding PLPA, 1900 from competent authority before executing development works.
- VII. You shall make arrangement for water supply, sewerage, drainage etc. to the satisfaction of DGTCP till these services are made available from external infrastructure to be laid by HUDA.
- VIII. You shall convey the 'Ultimate Power Load Requirement' of the project to the concerned power utility, with a copy to the Director, within two months period from the date of grant of license to enable provision of site in your land for Transformers / Switching Station/Electric Sub-Stations as per the norms prescribed by the power utility in the zoning plan of the project.
- IX. You shall provide the rain water harvesting system as per Central Ground Water Authority Norms/Haryana Govt. notification as applicable.

- X. You are aware that the development/construction cost of 24/30 m wide road/major internal road is not included in the EDC rates and you shall pay the proportionate cost for acquisition of land if any, alongwith the construction cost of 24/30 m wide road/major internal road as and when finalized and demanded by the Director General Town & Country Planning, Haryana.
- XI. You shall provide the solar water heating system as provisions of HAREDA and shall be made operational where applicable before applying for an occupation certificate.
- XII. You shall arrange electric connection from outside source for electrification of your colony from HVPN and shall install the electricity distribution infrastructure as per the peak load requirement of the colony for which you shall get the electrical (distribution) service plan / estimates approved from the agency responsible for installation of external electric services i.e. HVPN/UHBVNL/DHBVNL Haryana and complete the same before obtaining completion certificate for the colony.
- XIII. You shall submit compliance of Rule 24, 26, 27 & 28 of Rules 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, and shall inform account number and full particulars of the scheduled Bank wherein you have to deposit thirty percentum of the amount from the ~~Flat~~/shop buyers for meeting the cost of Internal Development Works in the colony.
- XIV. You shall keep the pace of construction atleast in accordance with sale agreement executed with the buyers of the flats as and when scheme is launched.
- XV. You shall pay the labour cess as per policy instructions issued by Haryana Government vide Memo No. Misc. 2057-5/25/2008/2TCP dated 25.02.2010.
- XVI. You shall not pre-launch/sale of space before approval of the building plans.
- XVII. You shall not use the ground water for the purpose of construction of building. The building plans shall be approved only after the source of water for construction purposes is explained to the satisfaction of HUDA Authority in terms of orders of the Hon'ble High Court dated 16.07.2012 in CWP's no. 20032 of 2008, 13594 of 2009 and 807 of 2012.
- XVIII. You shall permit the Director or any other officer authorized by him to inspect the execution of the layout and the development works in the colony and to carry out all directions issued by him for ensuring due compliance of the execution of the layout and development works in accordance with the license granted.
- XIX. You shall obey all the directions/restrictions imposed by the Department from time to time in public interest

- XX. You shall specify the detail of calculations per Sqm/per sq ft, which is being demanded from the flat/shop owners on account of IDC/EDC, if being charged separately as per rates fixed by Govt.
7. You shall complete the demarcation at site within 7 days and will submit the demarcation Plan in the office of District Town Planner, Gurgaon within 15 days of issuance of this memo.
8. You shall submit a certificate from the District Revenue Authority stating that there is no further sale of the land applied for license till date and applicant companies/individual are owners of the land.
9. You will intimate your official "email ID" to the Department and correspondence done by Department on this ID shall be treated as official intimation & legally valid.
10. To submit an affidavit duly attested by 1st Class Magistrate, to the effect that you have not submitted any other application for grant of license for development of the said land or part thereof for any purpose under the provisions of the Haryana Development and Regulation of Urban Areas Act, 1975 or any application seeking permission for change of land use under the provision of the Punjab Schedule Roads and Controlled Areas restrictions of Unregulated Development Act, 1963 or have not applied for license / permission under any other law for the time being in force.
11. You shall enhance the paid up capital of Ocimum Estates Pvt. Ltd. to ₹ 12.00 crores & submit requisite documents, before issuance of the license.


