- That you will make arrangement for water supply, sewerage, drainage etc. to the 11. satisfaction of DGTCP till these services are made available from external infrastructure to be laid by HUDA.
- That you will have no objection to the regularization of the boundaries of the 12. licensed area through give and take with HUDA if required for integration of services and for planned development and will abide by the decision of the competent authority.

  - That you will not encroach upon 2 karam wide revenue rasta bifurcating the site into two parts and the same will be kept unobstructed and hazzle-free.
