Affidavit cum Declaration

Affidavit cum Declaration of M/s Signatureglobal Homes Private Limited having its office at Unit No. 1309, 13th Floor Dr.Gopal Das Bhawan, 28 Barakhamba Road, New Delhi 110001 of the Proposed Affordable Plotted Colony "Signature Global Park-IV" by Mr. Sanjay Kumar Varshney, Mr. Manish Garg & Mr. Ajay Kumar duly authorized by the promoter of the proposed project, vide its/his/their authorization dated 20th January, 2020.

We, Signatureglobal Homes Private Limited do hereby solemnly declare, undertake and state as under:

1. That M/s Signatureglobal Homes Private Limited has a legal title to the land admeasuring 10.53125 acres on which the development of the project is proposed and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
2. That the said land is free from all encumbrances.

8. That M/s Signatureglobal (India) Private Limited shall take all the pending approvals on time, from the competent authorities.
9. That M/s Signatureglobal Homes Private Limited has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.



10. That M/s Signatureglobal Homes Private Limited shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.

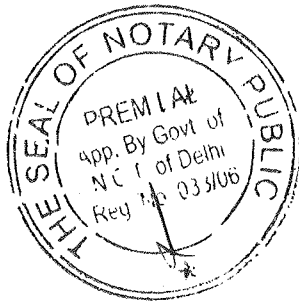
