Affidavit cum Declaration

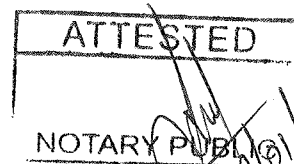
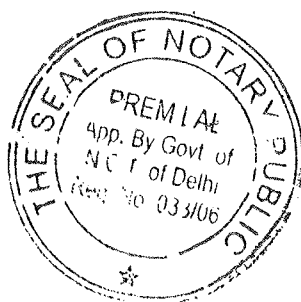
