AFFIDAVIT CUM DECLARATION

cum Declaration of Mr. Kushagr Ansal, S/o Shri Deepak Ansal, R/o 82, Jor Bagh, New 10003, Wholetime Director and CEO of M/s Ansal Housing & Construction Ltd., r of the ongoing project duly authorized by the promoter of the proposed project, vide its ation dated 29.05.2017;

agr Ansal duly authorized by the promoter of the proposed project do hereby solemnly e undertake and state as under:

- That the applicants are developing a commercial project "ANSALS HUB 83 BOULEVARD" of area admeasuring 2.60 acres (License No. 7) of 15.09.2010; in Sector-\$3, Gurgaon, Haryana.
- That the land title is in favour of M/s Samyak Projects Pvt. Ltd. The project is being developed by M/s Ansal Housing & Construction Ltd., a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
- That there is no encumberance on the said project details of which have already been given in the accompanying application and the same is not being repeated for the sake of brevity.
- That the time period within which the project shall be completed by the promoter is 31st December, 2020.
- That seventy per cent of the amounts realized by me for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be muntained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.
- 7. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 8. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

That the promoter shall take all the pending approvals on time, from the competent

That the promoter have furnished such other documents as have been prescribed by the Act nd the rules and regulations made thereunder and shall furnish any other further documents as and when directed by the authority.
