Applicant M/s Orries Infrastructure Pvt. Ltd., J-10/5, Phase II, Mchruli, Gurgaon road Gurgaon vida letter no. 102 dated 02.06.2010 made a request in connection with land measuring 25.018 Acres having Khasra. No. 75 Killa No.25/2 Rect. No. 26 Killa No. 16, 17, 19/2, 20, 21, 22/1, 22/2, 23/1, 23/2, 25 Rect. No. 27 Killa No. 1, 10, , 12, 13/1, 20 Rect. No. 29 Killa No. 1/1/2, 1/2/2, 2/2/2, 9, 10, 11/1/1/1, Rect. No. 30 Killa No. 1/1, 1/2, 2/1, 2/2, , 4/1, 4/2/1, 4/2/2, 4/3, 5, 6, 7/2, 8/1, 10, 13/2/1, 14/1/1 Rect. No. 31 Killa No. 6 land located at Village Badha District Gurgaon. Applicant made a proposal to use this land for Housing Project. In continuation of report submitted by RFO, Gurgaon vide Letter No 340-G dated 15.06.2010 and approval from C.F. South Circle, Gurgaon vide letter No. 2808 dated 26.07.2010, it is made clear that: -

Above said land is not part of notified / closed area under IFA 1927/FCA1980/Specific section 4&5 of PLPA 1900/ WLPA1972/ or any other forest land.

It is clarified that by the Notification No. S.O.121/PA.2/1900/S.4/97 dated 28th November, 1997, all revenue estate of Gurgaon District is notified u/s 4 of PLPA 1900 and S.O.113/PA.2/1900/S.3/97 dated 17th November, 1997 u/s 3 of PLPA. The area is however not recorded as forest in the Government record but felling of trees is strictly prohibited without the permission of Divisional Forest Officer, Gurgaon.

The proposed site is situated along the notified protected forest strip along Kherki-Daula-Badha road R/Side if approach is required from protected Forest by user agency, the clearance/regularization under Forest Conservation Act 1980 will be required. Without prior clearance from Forest Department, the use of Forest land for approach road is strictly prohibited.

As per record with the Forest Department, Gurgaon, the area does not fall under Aravalli Project Plantation done by the Forest Department.

All other statutory clearance mandated under the Environment Protection Act. 1986 shall be obtained as applicable by the project proponents from the concerned authorities.

The project proponent will not violate any Judicial Orders/ Pronouncement issued by the Hon'ble Supreme Court/High Courts.

Clarification regarding Applicability of forest laws on land Applied by M/s. Orris Infrastructure Pvt. Ltd, J-10/5, DLF Ph-II, Merauli Road, Gurgaon, Haryana.

Applicant M/s. Orris Infrastructure Pvt. Ltd, J-10/5, DLF Ph-II, Merauli Road, Gurgaon, Haryana vide letter no. Nil dated 01.02.2012 made a request in connection with land measuring 4.05 Acres having Rect. No. 26 Killa No. 5/2, 15, 24 Rect. No. 27 Killa No. 13/2/1, 13/3, 13/4, 19/2, 21/1/1. Land located at village Badina, District Gurgaon. Applicant made a proposal to use this land for Group Housing Project Purposes. In continuation of report submitted by RFO, Gurgaon vide Letter No. 1086-G dated 10.02.2012 and approval from C.F. South Circle, Gurgaon vide letter No. 5900 dated 06.03.2012, it is made clear that: -

As per record available above said land is not part of notified / closed area under IFA 1927/ FCA1980/ Specific section 4 & 5 of PLPA 1900/ WLPA1972/ or any other forest land.

It is clarified that by the Notification No. S.O.121/PA.2/1900/S.4/97 dated 28th November, 1997, all revenue estate of Gurgaon District is notified u/s 4 of PLPA 1900 and S.O.113/PA.2/1900/S.3/97 dated 17th November, 1997 u/s 3 of PLPA. The area is however not recorded as forest in the Government record but felling of any tree is strictly prohibited without the permission of Divisional Forest Officer, Gurgaon.

If approach is required from Protected Forests by the user agency, the clearance/regularization under Forest Conservation Act 1980 will be required. Without prior clearance from Forest Department, the use of Forest land for approach road is strictly prohibited.

As per record with the Forest Department, Gurgaon, the area does not fall under Aravalli Project Plantation done by the Forest Department.

All other statutory clearance mandated under the Environment Protection Act. 1986 or any other Act/order shall be obtained as applicable by the project proponents from the concerned authorities.

The project proponent will not violate any Judicial Order/ Pronouncement issued by the Hon'ble Supreme Court/ High Courts.

It is clarified that the Hon'ble Supreme Court has issued various judgment dated 06.05.02002, 29.10.2002, 16.12.2002, 18.03.2004 etc. pertaining to Aravalli region in Haryana.

Since the project site falls in the area closed under General Section 4 of PLPA, 1900; in which felling of trees etc. prohibited without prior permission of competent authority. The project proponent shall not fell any tree from the site without prior permission of competent authority.
