It is intimated that zoning plan for 10.175 acres (Licence No. 105 of 2011 dated 11.12.2011) for group housing has already been approved by DGTCP (refer drawing No. DGTCP-2928 dated 12.12.2011). The applicant company has obtained LOI for the additional area measuring 8.875 and 1.99375 acres. The revised alignment of sector dividing road of sectors 112 and 113 has been approved by DGTCP, Haryana vide his memo no. 4293 dated 26.03.2012. Now, the applicant company has applied for revised/combined demarcation plan for the area measuring 10.175+1.99375+8.875 = 21.04375 acres of group housing colony in sectors-112 & 113, Gurgaon.

The report received from District Town Planner Gurgaon reveals that the dimensions shown on the demarcation plan have been found correct on the ground. As per dimensions shown on the plan, the total area of the site works out to 21.188 acres against the 21.04375 acres granted in licence and LOIs. The areas of the site falling under sector, roads and road widening is given below in the table:-

Area falls in sector	8.937	12.251	21.188
Area under road widening	0.56	1.037	1.597
Area under service road	0.591	0.78	1.371

Hence, the balance area of the site is 21.188-1:371=18.22 acres. No HT /IOC pipe line pass over/through the site. The site has been demarcated with wire fencing. The site is reported to be levelled and vacant.
