
Sub.: Clarification regarding Applicability of forest laws on land of M/s. S A Infratech Pvt. Ltd., C-10, C-Block Market, Vacant Vihar, New Delhi.

Applicant M/s. S A Infratech Pvt. Ltd., C-10, C-Block Market, Vacant Vihar, New Delhi vide letter no. Nil dated 02.11.2010 made a request in connection with land measuring 60.511 Acres having Khasra No. 74min, 75min, 76, 77, 78, 79, 80, 161/2, 165/1, 165/4, 166/1, 167, 168, 169, 170/1min, 170/2min, 171, 172, 173, 174min, 175min, 176/1, 176/2, 185, 186min, 415/373/187/2, 416/374/187/1, 416/374/187, 418/374/187, 415/373/187/2/1, 417/374/187/2, 188/1, 188/2min, 375/189, 375/189/2min, 191/2min, 192, 420/193/2, 201, 202, 203, 204, 205, 222, 225, 226, 228, 378/227, 379/229/1, 379/229/2, 230, 231, 232, 233, 234, 235. Land located at Village Gadoli Kalan District Gurgaon. Applicant made a proposal to use this land for Group Housing Purpose. In continuation of report submitted by RFO, Gurgaon vide Letter No 948-G dated 23.11.2010 and approval from C.F. South Circle, Gurgaon vide letter No. 5886 dated 10.01.2011, it is made clear that: -

- Above said land is not part of notified / closed area under IFA 1927/FCA1980/Specific section 4 & 5 of PLPA 1900/ WLPA1972/ or any other forest land.
- It is clarified that by the Notification No. S.O.121/PA.2/1900/S.4/97 dated 28th November, 1997, all revenue estate of Gurgaon District is notified u/s 4 of PLPA 1900 and S.O.113/PA.2/1900/S.3/97 dated 17th November, 1997 u/s 3 of PLPA. The area is however not recorded as forest in the Government record but felling of trees is strictly prohibited without the permission of Divisional Forest Officer, Gurgaon.
- If approach is required from Protected Forest by the user agency, the clearance/regularization under Forest Conservation Act 1980 will be required. Without prior clearance from Forest Department, the use of Forest land for approach road is strictly prohibited.
- As per record with the Forest Department, Gurgaon, the area does not fall under Aravalli Project Plantation done by the Forest Department.
- All other statutory clearance mandated under the Environment Protection Act, 1986 or any other Act/order shall be obtained as applicable by the project proponents from the concerned authorities.
- The project proponent will not violate any Judicial Orders/ Pronouncement issued by the Hon'ble Supreme Court/High Courts.






