Sub:- Renewal of NOC for ground water withdrawal to M/s Model Economic Township Ltd. (Formerly Reliance Haryana SEZ Ltd.), in respect of their existing Model Economic Township located at Village Dadri Toe, Yakubpur, Sondhi, Block & District Jhajjar, Haryana - reg.

Refer to your application dated 31.01.2017 on the above cited subject. Based on recommendations of Regional Director, CGWB, North Western Region, Chandigarh vide their office letter No. 4(172)A-HR/MITL/NWR/S&I/2017-503 dated 03.04.2017, and further deliberations on the subject, the renewal of NOC issued vide this office letter of even no. dated 24.11.2014 is hereby accorded to **M/s Model Economic Township Ltd. (Formerly Reliance Haryana SEZ Ltd.), in respect of their existing Model Economic Township located at Village Dadri Toe, Yakubpur, Sondhi, Block & District Jhajjar, Haryana**, for a period of three (3) years from the date of issue of this letter. The renewal is however subject to the following conditions:-

1. The firm may abstract **3,388 m³/day** of ground water (**not exceeding 12,36,620 m³/year**) through existing twenty four (24) tube wells only. No additional ground water abstraction structures shall be constructed for this purpose without prior approval of the CGWA.
2. All the wells shall be fitted with water meter by the firm at its own cost and monitoring of ground water abstraction shall be under taken accordingly on regular basis, at least once in a month.
3. **M/s Model Economic Township Ltd. (Formerly Reliance Haryana SEZ Ltd.)**, shall, continue to implement ground water recharge measures to the tune of **15,40,000 m³/year** for augmenting the ground water resources of the area in consultation with the Regional Director, CGWB, North Western Region, Chandigarh. Firm shall also undertake periodic maintenance of recharge structures at its own cost.
4. The firm shall continue to execute monthly ground water level monitoring in the project area through three (3) nos. of piezometers fitted with digital water level recorder having telemetry system at suitable locations in consultation with the

CGWB, North Western Region, Chandigarh. The firm shall share the user ID and password with the Regional Director, CGWB, North Western Region, Chandigarh.

5. The ground water quality shall be monitored twice in a year during pre- monsoon and post- monsoon periods.

6. The ground water monitoring data in respect of S. No. 2, 4 & 5 shall be submitted to CGWB, North Western Region, Chandigarh on regular basis at least once in a year.

7. The firm shall ensure proper recycling and reuse of waste water after adequate treatment.

8. Action taken report in respect of S.N o. 1 to 7 shall be submitted to CGWA within one year period.

9. The renewal is liable to be cancelled in case of non-compliance of any of the conditions as mentioned in S. No. 1 to 8.

10. This NOC is subject to prevailing Central/State Government rules/laws or Court orders related to construction of tubewell/ground water withdrawal/construction of recharge or conservation structures/discharge of effluents or any such matter as applicable.

11. This NOC does not absolve the applicant / proponent of his obligation / requirement to obtain other statutory and administrative clearances from other statutory and administrative authorities.

12. The NOC does not imply that other statutory / administrative clearances shall be granted to the project by the concerned authorities. Such authorities would consider the project on merits and be taking decisions independently of the NOC.
