- 5. That the amounts will be withdrawn from the said account by the promoter in proportion to the phase wise completion of the project.
- 6. That the promoter can withdraw the amount from that account only after it is certified by an engineer, architect, and a practiced chartered accountant i.e. withdrawl is in proportion to the phase wise completion of the project.
- 7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That the promoter shall take all the pending approvals if any in a time bound manner, from the competent authorities.
- 9. That the promoter will furnish such other documents as may be necessary under the acts rules and regulations made thereunder.
- 10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
