

Whereas, the parties hereinabove have entered into a collaboration agreement dated 15.07.2011, having Registration No. 10439, at Bahi No. 1, at page No. 22 of Zild No. 12963, additional copy pasted at Bahi No.1, at page no. 12-13 of Zild No. 1436, to undertake the constructions and development of a commercial colony on the terms and conditions as mutually agreed therein (hereinafter referred to as the "Said Collaboration").

And whereas, the party of the second part has obtained a letter of intent bearing Memo No. LC-2668-JE (VA)-2013/42687 dated 13.06.2013 from the Director General, Town and Country Planning, Haryana (DGTCP) for the development of lands covered by the Said Collaboration (hereinafter referred to as The Said "LOI").

And whereas, to comply with the terms of the said LOI, Parties herein have decided to enter into this Supplementary Collaboration Agreement.

NOW THIS AGREEMENT WITNESSETH AND PARTIES HEREBY AGREE AS UNDER:-

- 1. That in Party of the Second Part shall be responsible for the compliances of all the terms and conditions of the License/ Provisions of Haryana Development & Regulation of Urban Areas Act of 1975 and Haryana Development & Regulation of Urban Areas Rules 1976, till the grant of Final Completion Certificate in respect of the proposed colony, covered by the said Collaboration or relieved of the responsibility by the DGTCP, whichever is earlier.
- 2. That the Said Collaboration Agreement and this Supplementary Collaboration Agreement shall remain irrevocable and no modification/ alteration etc. in the terms and conditions thereof can be undertaken except after obtaining prior approval of the DGTCP, Haryana.
- 3. That all the Terms and Conditions of the said Collaboration shall remain


