That you shall construct portion of service road, internal circulation roads, forming the part of site area at your own cost and shall transfer the land falling within alignment of same free of cost to the Govt. u/s 3(3) (a) (iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.

That you shall construct the community building at your own cost, or get constructed by any other institution or individual at its costs, the community building on the lands set apart for this purpose, within four years from grant of licence extendable by the Director for another period

That you shall submit compliance of Rule 24, 26, 27 & 28 of Rules 1976 & S. Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, and shall inform account number and full particulars of the scheduled bank wherein you have to deposit thirty percentum of the amount from the floor/space holders for meeting the cost of Internal Development Works in the colony.

- That you shall permit the Director or any other office authorized by him t. to inspect the execution of the layout and the development works in the colony and to carry out all directions issued by him for ensuring due compliance of the execution of the layout and development works in accordance with the license granted.
- That you shall deposit thirty per centum of the amount release, from u. time to time, by you, from the flat owner within a period of ten days of its realization in a separate account to be maintained in a scheduled bank. This amount shall only be utilized by you towards meeting the cost of internal development works in the colony.
- That you shall not give any advertisement for sale of commercial area ٧. and flat in affordable Group Housing area before the approval of layout plan / building plans of the same.
- That you shall pay the labour cess as per policy instructions issued by w. Haryana Government vide Memo No. Misc. 2057-5/25/2008/2TCP dated 25.02.2010.
- That you shall keep pace of construction atleast in accordance with sale X. agreement executed with the buyers of the flats as and when scheme is launched.
- That you shall furnish the Bank Guarantee against the total realization у. from the project at the rate of 15% within 90 days from the commencement of the project as per policy dated 19.08.2013.
- That you shall abide by the terms and conditions as per Affordable z. Housing Policy-2013 notified on 19.08.2013 as amended from time to time.
- That you shall obey all the directions/restrictions imposed by the aa. Department from time to time in public interest.
