**Sub: Request for sewerage connection for our Group Housing Project "Godrej Summit" on land measuring 22.1234 acres being developed by Godrej Project Development Ltd in collaboration with Magic Info Solutions Pvt Ltd (Lic No. 102 of 2011 dated 07.12.2011) falling in Sector 104 Gurugram.**

**Ref:- Your application received on dated 13.07.2018.**

You are hereby authorized to disposed off your following P.H. installation to sewer line in existing M.H. through 200 mm dia pipe sewer. Godrej Projects Development Ltd, are allowed to disposed off surplus treated effluent of STP in HSVP sewer line through pumping if required. In addition you are requested to furnish an Affidavit that you will have to deposit the monthly sewerage charges for maintenance of HSVP sewer on the rates fixed by HSVP from time to time and sewerage connection is sanctioned on the following terms & conditions: -


1. The Sewer connection subject to condition that the master sewer line of HSVP is yet not been functional and you will not make connection in the HSVP master sewer line until the line is made functional as undertaking submitted by you.
2. Sewer connection shall be released in the presence of the representative of the department (HSVP only authorized by the Executive Engineer, concerned).
3. The maintenance of internal sewer lines and connections etc. in all respect, shall be the owners responsibility and at his own cost.
4. The rate shall be changed as fixed by the Chief Administrator, HSVP from time to time and shall binding upon Godrej Projects Development Ltd,
5. Sewer connection shall be released in the presence of the representative of Godrej Projects Development Ltd, and the monthly charges shall also be paid by the firms regularly.
6. The connection shall be maintained strictly as per rules and regulations framed by HSVP.
7. Sewer connection will be utilized and limited for Godrej Projects Development Ltd,.
8. For any dispute in connection with the release of sewer connection/maintenance and disconnection etc. for the said sewer connection and matter shall be referred by any of the two parties to the concerned SuperIntending Engineer, HSVP, Circle, Gurugram and his omission in the matter shall be final and legally binding on both the parties.
9. The sewerage charges for the whole complex will be deposited by Godrej Projects Development Ltd,
10. The basis of rates fixed by HSVP from time to time.

11. It will be ensured by Godrej Projects Development Ltd, that sewerage effluent to be disposed off in HSVP sewer with the permissible limits as prescribed by the Haryana Pollution Water and Control Board.
12. Amount of Rs. 350000/- has already been deposited in HSVP, Division No. V, Gurugram by the above said firm on account of security charges and sewer connection fee vide D.D. No. 742430 dated 06.07.2018 of HDFC Bank Gurugram.
13. It will be ensured by the Godrej Projects Development Ltd, that sewer connection will be made at site after functioning the STP of HSVP and Godrej Projects Development Ltd, will make the connection only when the sewer line will be available at site and Godrej Projects Development Ltd, will not go for any litigation for the above subject and if the damage occurs during the process to the existing infrastructures/facilities such as water supply, sewerage, storm water drainage line, petroleum, gas pipe line and telephone line etc the same will be rectified by the firm at his own cost and to the satisfaction of the Engineer-in-Charge.
14. Before carrying out excavation work on petroleum & gas pipe line prior permission to be taken from concerned company.
15. Rates of monthly sewerage charges will be @ 20% of water bills notification circulated vide Chief Administrator HSVP, Panchkula Endst No. 14928-950 dated 23.01.2018 w.e.f 01.01.2018.
16. The connection cannot be extended to any other person or transferred to any other occupant
17. The road cut permission will be obtained from the concerned Executive Engineer before making sewer connection.
18. It may also be made clear to the colonizer that he shall also comply with the orders passed by National Green Tribunal:-
  - i. The direction given National Green Tribunal dated 26.11.2014, 04.12.2014 and 19.01.2015 in original Application No. 21 of 2014 in the matter of Vardhman Kaushik V/s Union of India and Others shall be implemented by colonizer.
  - ii. Implementation of instruction issued by Hon'ble NGT during hearing held on OA No. 21 of 2014 and OA No. 95 of 2014 in the matter of Vardhman Kaushik V/s Union of India and Others shall be complied with by colonizer.
  - iii. NGT orders in Application No. 45 of 2015 & M.A No. 126 OF 15 titled as Haryana Welfare Association V/s State of Haryana Gurgaon.
