Please refer to your office memo No. Ch-2/DRG-1722/GGN dated 22.01.2015 vide which you have recommended the subject cited case for approval.

The load of 9928 KW or 11031 KVA of M/s Magic Info Solutions Pvt. Ltd, Sec-104, Gurgaon under BS/Domestic category on 33 KV level through 33 KV independent feeder to be emanated from proposed 220 KV S/Stn., Sec-102 has been sanctioned subject to the conditions given as under:-

- 1. SE/OP, DHBVN, Gurgaon should personally ensure that BG deposited by the developer is commensurate with the ultimate load.
- 2. The load of M/s Magic Info Solutions Pvt. Ltd., Sec-104, Gurgaon under bulk domestic category with connected load of 9928 KW or 11031 KVA applied vide A&A No. 211256478 BS/DS dated 30.10.2014 will be fed on 33 KV level through an independent 33KV underground feeder with 33KV XLPE cable of size 300 mm2 from proposed 220 KV S/Stn Sec-102 with installed capacity 2X100 MVA, 220/33KV Power Transformers.
- 3. The developer will deposit share cost required, if any, as per the instructions of HVPN.
- 4. The consumer will enter into tripartite agreement with HVPN and DHBVN.
- 5. No applicant, senior to the instant applicant/ consumer is waiting for sanction of load / extension of load.
- 6. Processing charges, Consumption security & other applicable charges be recovered from the developer as per Nigam Instruction.
- 7. Documentary proof in support of the identification of the authorized signatory i.e. copy of ration card, driving license etc. shall be obtained from the applicant / consumer.
- 8. The developer will submit documentary proof in support of ownership of land.
- 9. Non-judicial stamp worth Rs. 3/- on the left corner of A&A be, got affixed by the SDO before taking further action.
- 10. The consumer will not raise any claims against the department for un-notified unscheduled power cuts, which are beyond the control of the department and an undertaking will be obtained from him.

11. The developer shall comply with the instructions of the Nigam issued by this office time to time.

- 12. The HT brochure may contain old instructions, as such an additional affidavit be obtained from the consumer to abide by the provision of the Electricity Act 2003 and complying of all the instructions of SMI & Sales Circular issued as well as amended by the Nigam from time to time before release.
- 13. Necessary clearance from various Govt. Department i.e. CEI, Pollution Control Board etc. shall be taken.
- 14. The tariff shall be charged from the consumer in accordance with tariff schedule approved by HERC.
- 15. The erection of 33 KV underground independent feeder as referred above shall be at the consumer cost and as per Nigam's specification and design.
- 16. The developer shall install 33/0.4 KV DTs of appropriate rating commensurate to ultimate load and conforming to latest Technical specifications circulated by Planning & Design Wing of DHBVN.
- 17. Inspection of material to be used will be got carried out from DHBVN Authorities and inspection charges @ 1.5% of the estimated cost of work shall be paid by the applicant to the Nigam.
- 18. The company shall erect overhead or underground HT lines as per specification and design of the Nigam.
- All other formalities as required as per instruction issued/adopted by Nigam time to time shall be completed.
- 20. Metering equipments including CTs of matching capacity as per specifications / design of Nigam shall be provided at S/Stn. as per Nigam instructions.
