



Affidavit cum Declaration of M/s Signatureglobal Homes Private Limited having its office at Unit No. 1309, 13th Floor Dr. Gopal Das Bhawan, 28 Barakhamba Road, New Delhi 110001 of the Proposed Affordable Plotted Colony "Signature Global Park-IV" by Mr. Sanjay Kumar Varshney, Mr. Manish Garg & Mr. Ajay Kumar duly authorized by the promoter of the proposed project, vide its/his/their authorization dated 20<sup>th</sup> January, 2020.

We, Signatureglobal Homes Private Limited do hereby solemnly declare, undertake and state as under:

- 1.
