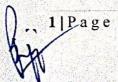

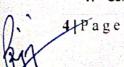

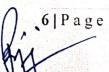

- 1. As per the revenue record for the period 2012-13 ownership is vested in Balbir Singh, Ashok Kumar, Narendra Singh @ Narendra Kumar, Nihal Singh and Kanwal Singh all sons of Late Shri Ramswarup. Subsequently Balbir Singh has expired and thus his property devolves upon his legal heirs.
- 2. As per revenue record Kanwal Singh is son of Late Shri Ramswarup, however, in sanction letter his name is appearing as Kamal Singh.
- 3. Part of land has been mortgaged with Punjab and Sind Bank for the sum 23,60,98,000/- and the same finds mentioned in revenue record.
- 4. There have been other seven mortgage/charge registered against ILD Private Limited and the details have been mentioned hereinabove. Clarification should be sought from ILD Private Limited about the following charges created against them:-

5. There have been numerous litigations against ILD Developers Pvt. Ltd., few of them have been detailed hereinabove, besides the same there can be several other litigations being pending/filed against ILD Developers Pvt. Ltd.

### D. CONCLUSION ON TITLE OF PLOT

- 1. Title of Plot is not in dispute, owners have not been found to have filed any litigation against Developer ILD Pvt. Ltd. and neither the Developers have filed any litigation against owners.
- 2. That no interse litigation between owners was traceable.
- 3. Part of plot has been mortgaged with bank.

### **E. CONCLUSION ON LEGAL CASES**

- There have been numerous cases filed against ILD Developers Pvt. Ltd., said cases can be in respect of present project launched by ILD Developers Pvt. Ltd.

- 4. Crime Investigation online portal with the name "Cobra Post" has carried secret investigation against ILD and in its report it has been stated that ILD is accepting huge amount of black money in the sale of property. Said report is under consideration and thus in future there is a possibility that the ILD and its Directors might be booked under appropriate provisions.
