**Affidavit cum Declaration**

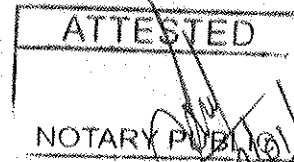
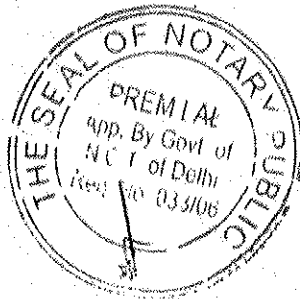
