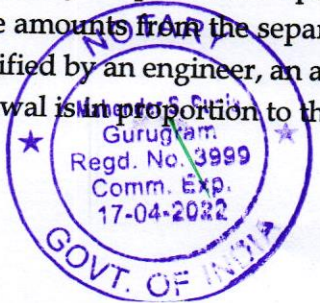
1. That M/s **GALLIUM PROPBUILD P LTD**, have a legal title to the land on which the development of the project is proposed

8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
