ORDER

Whereas, vide this office endst. no. DS-2008/7044-56 dated 14.08.2008, the Licence No. 155 of 2008 dated 14.08.2008 was granted to Unitech Infratech Pvt. Ltd. (now known as Gurgaon Infratech Pvt. Ltd.) for development of a Residential Group Housing Colony on the land measuring 16.1885 acres falling in the revenue estate of Village Fazilpur Jharsa, Sector 72, Gurgaon-Manesar Urban Complex.

- 4. The approval of all the plans earlier accorded and issued to Gurgaon Infratech Pvt. Ltd. (Unitech Infratech Pvt. Ltd.) shall now be deemed to be approved and issued in favour of Tata Housing Development Company Ltd., 3, Ground Floor, Naurang House, 21, Kasturba Gandhi Marg, New Delhi-110001.
- 5. These orders shall be read together with the Licence no. 155 of 2008 dated 14.08.2008 issued vide this office. The copy of Licence no. 155 of 2008, LC-IV agreement & Bilateral agreement are hereby enclosed.
