



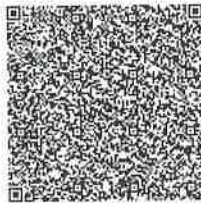

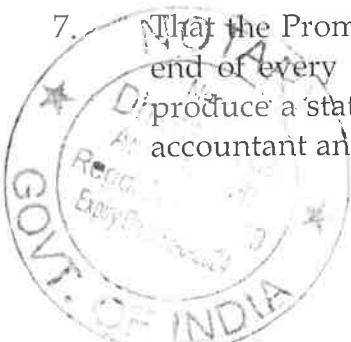

I, **Rakesh Roshan**, director of the Promoter Company of the proposed project known as **District Walk A**, affirming this affidavit based on the information provided by the Head of the Department of Finance, Accounts, Legal and Land Amortization etc.

1. That the person's as mentioned in the land schedule of the license has a legal title to the land on which the development of the proposed project is to be carried out and authenticated copy of the agreement between such owner and promoter for development of the real estate is enclosed herewith.

8. That the Promoter shall apply and endeavor to take all the pending approvals on time, from the competent authorities.
