

ORDER

License No. 76 of 2019 dated 30.07.2019 was granted in favour of Druzba Overseas Pvt. Ltd., Fragrance Construction Pvt. Ltd., Countrywide Promoters Pvt. Ltd., Impower Infrastructure Pvt. Ltd., Gitanjali Promoters Pvt. Ltd., Business Park Developers Pvt. Ltd., in collaboration with Countrywide Promoters Pvt. Ltd., for development of a Affordable Plotted Housing Colony (DDJAY) over an area measuring 6.70 acre (3.90 acres after migration from license No. 192 of 2007 and additional fresh area measuring 2.80 acres) falling in the revenue estate of Village Kheri Khurd, Sector-83, Faridabad, Haryana.
