यह पासपोर्ट भारत सरकार की संपत्ति है। इस पासपोर्ट के धारे में किसी पासपोर्ट अधिकारी से इसके धारक की यदि कोई सूचना मिलती है जिसमें पासपोर्ट लौटाने की मांग भी शामिल है तो उसका तुरंत अनुपालन किया जाए।

यह पासपोर्ट हाथ दुगुन किमी भी देन से बाहर न भेजा जाए। यह पासपोर्ट धारक यह उत्तरके द्वारा प्राधिकृत व्यक्तिके कब्जे में ही होना चाहिए। इसमें किसी भी प्रकार का पैरबन्धन या विकृति नहीं की जानी चाहिए।

पासपोर्ट गुप्त हो जाने, भोरी हो जाने अथवा चट्ट हो जाने पर उसकी सूचना भारत में सबसे निम्नतम पासपोर्ट अधिकारी को अथवा यदि पासपोर्ट यास्क विदेश में है तो निवृत्ततम भारतीय मिशन/कन्सुल और स्थानीय पुलिस को सम्प्राप्त हो जानी चाहिए । फिरलुन फूटलाछ के बाद ही दुष्प्रतिकेड पासपोर्ट जारी किया जाएगा ।

INDIAN CITIZENS RESIDENT ABROAD ARE ADVISED TO REGISTER
THEMSELVES AT THE NEAREST INDIAN MISSION/POST.

THIS PASSPORT IS THE PROPERTY OF THE GOVERNMENT OF INDIA. ANY COMMUNICATION RECEIVED BY THE HOLDER FROM A PASSPORT AUTHORITY REGARDING THIS PASSPORT, INCLUDING DEMAND FOR ITS SURRENDER, SHOULD BE COMPLIED WITH IMMEDIATELY.

THIS PASSPORT SHOULD NOT BE SENT OUT OF ANY COUNTRY BY POST. THIS SHOULD BE IN THE CUSTODY EITHER OF THE HOLDER OR OF A PERSON AUTHORIZED BY THE HOLDER. IT MUST NOT BE ALTERED OR MUTILATED IN ANY WAY.
