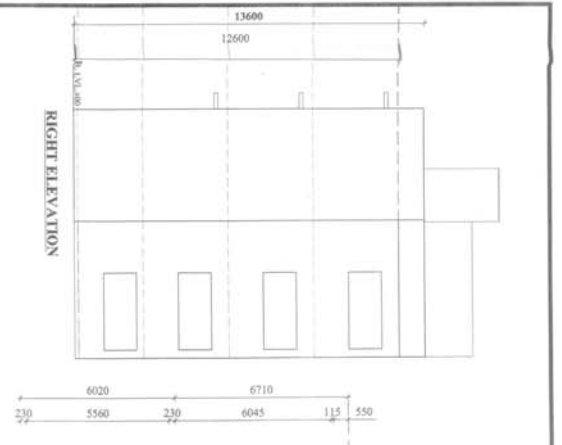

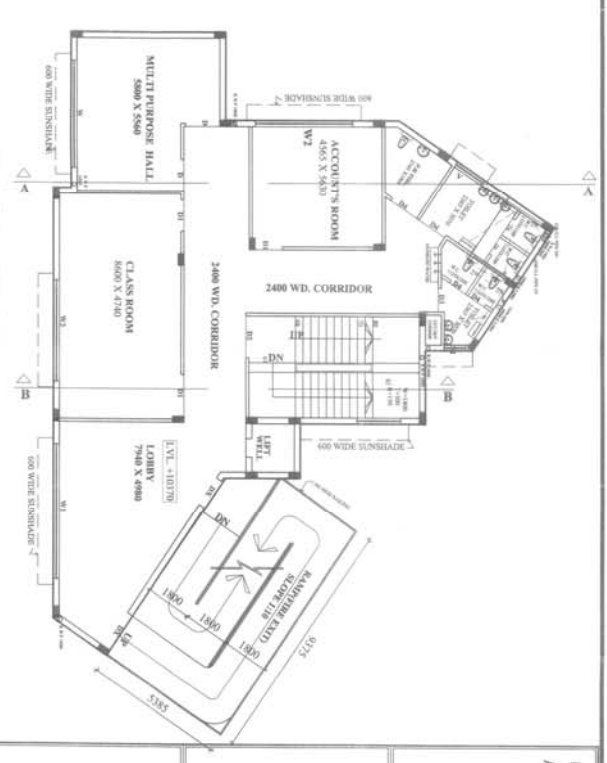

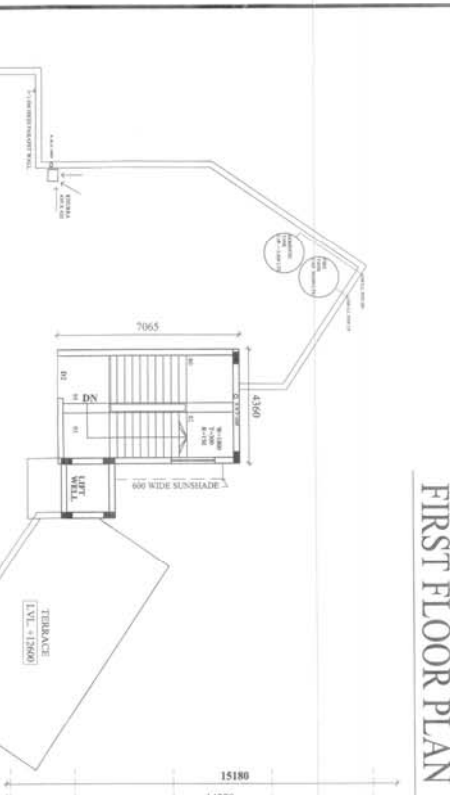
FIRST FLOOR PLAN



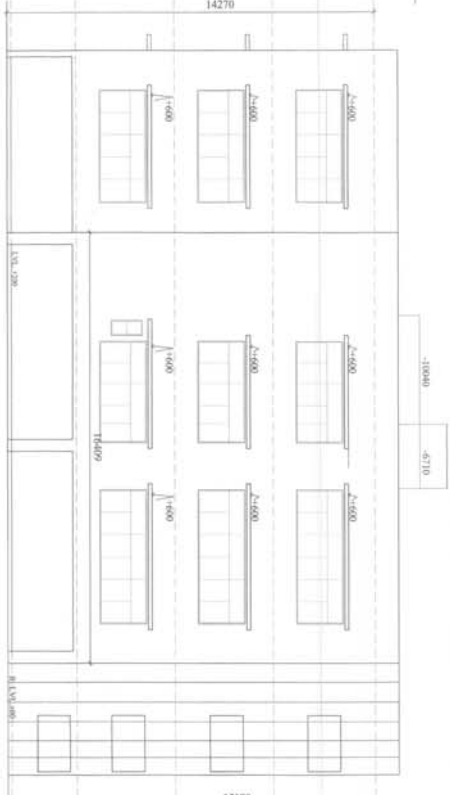
SECOND FLOOR PLAN



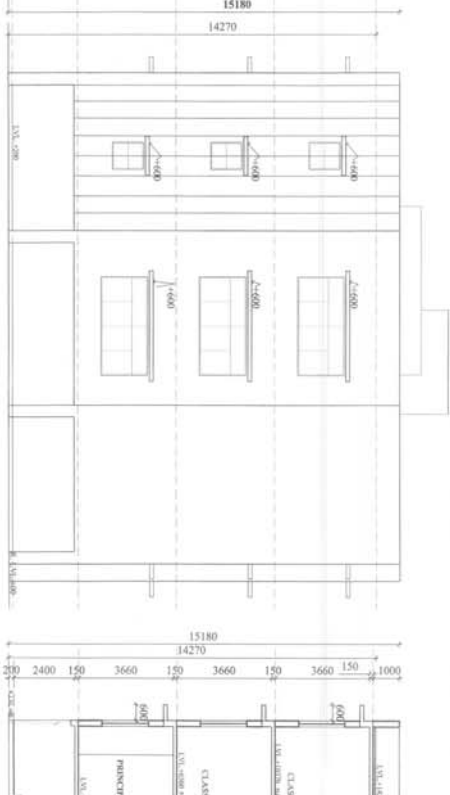

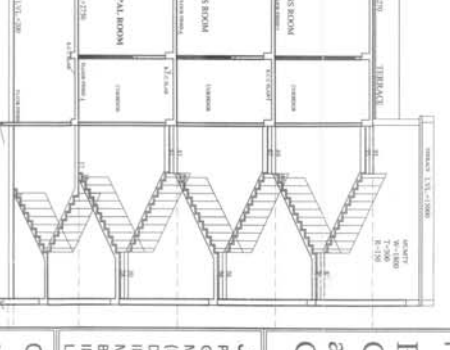
TERRACE FLOOR PLAN

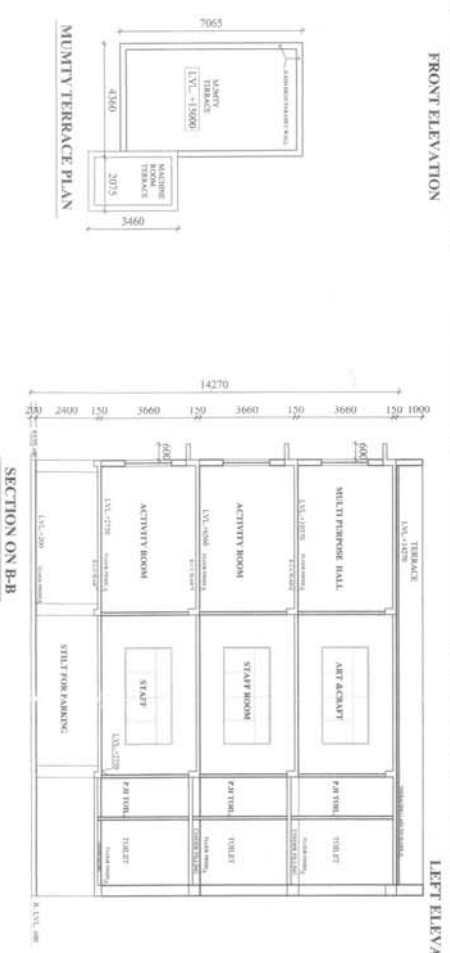

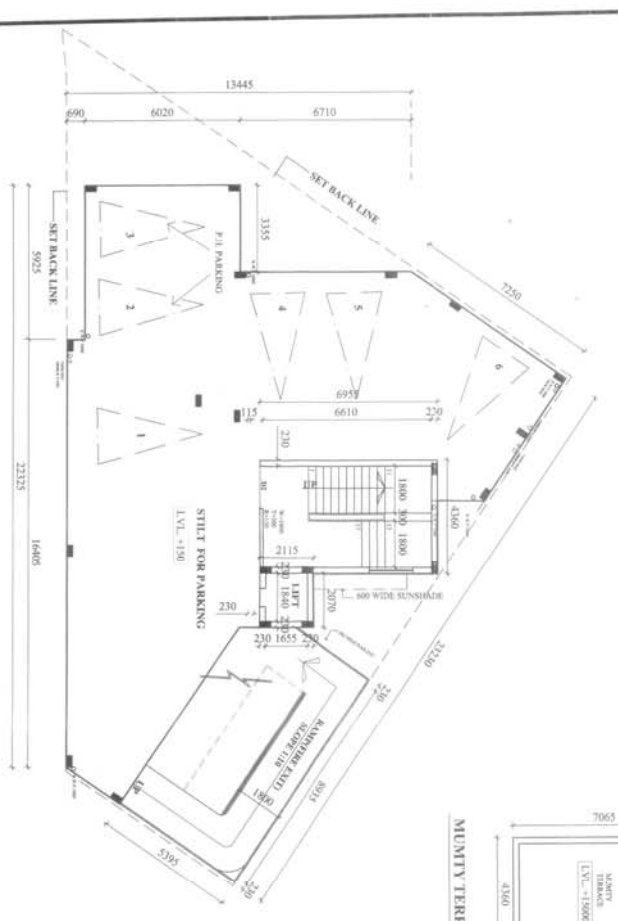

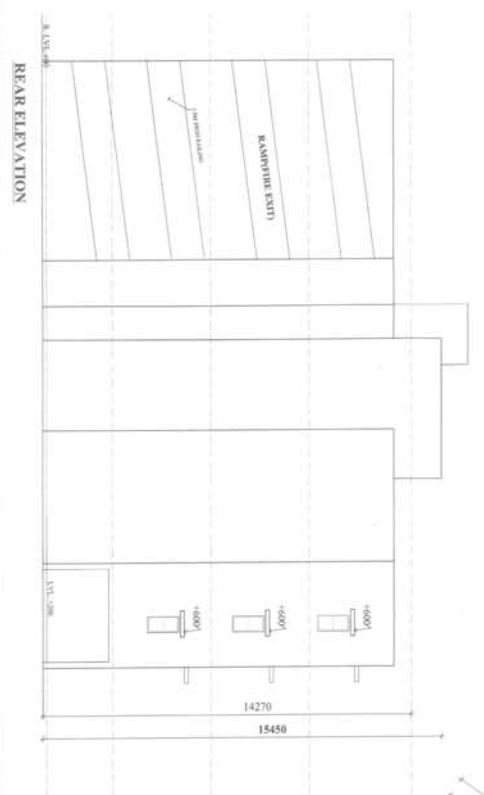
MUMTY TERRACE PLAN



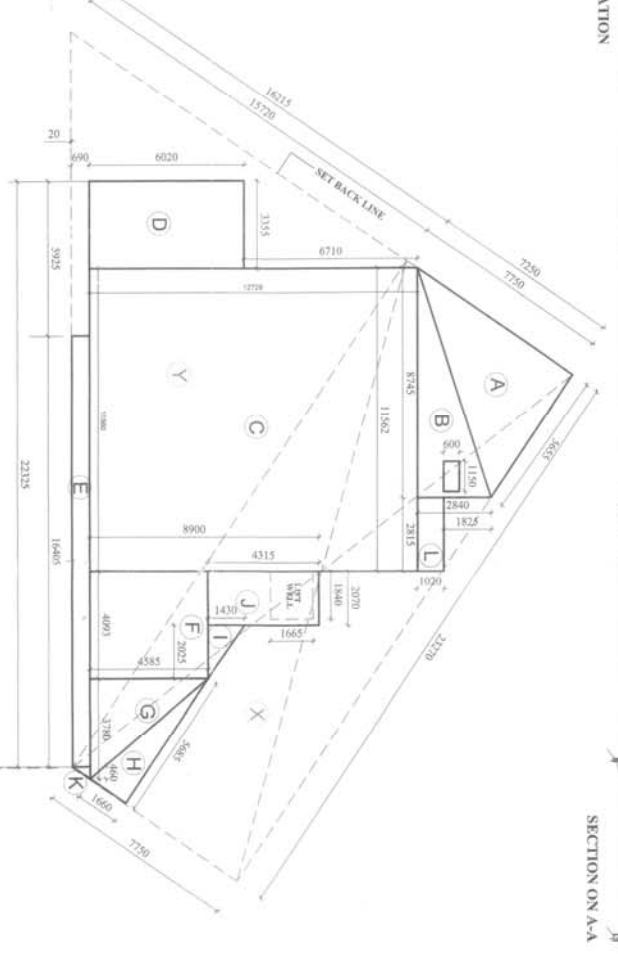
