We, Signatureglobal Homes Private Limited do hereby solemnly declare, undertake and state as under:



during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.


8. That M's Signatureglobal Homes Private Limited shall take all the pending approvals on time, from the competent authorities.
