- I, Mr. Mandeep Singh Oberoi, Director of the Promoter Company duly authorized by the promoter of the proposed project, do hereby solemnly declare, undertake and state as under:
- 1. That the Licensee has a legal title to the land (as per details mentioned in the enclosed application form) on which the development of the project is being carried out.
- 2. That the part of the said licensed land admeasuring 6.86875 Acres has been offered as collateral to AXIS Bank for availing non-fund based credit facility i.e. Bank Guarantee and the rest of the land is free from all encumbrances.
