


ORDER

Whereas, license No. 57 of 2014 dated 20.06.2014 was granted to JSR Buildcon Pvt. Ltd., Sh. Som Dutt S/o Sh. Chhajjan, S/Sh. Parshant, Pawan Ss/o Sh. Laxmi Narayan in collaboration with Pyramid Infratech Pvt. 


