Affidavit cum Declaration of Mr Virender, authorized Signatory of the promoter i.e. Shree Mahaluxmi Builders of the proposed project an area measuring 5.9378 acres falling in Kasba Karnal, sector 36 , Karnal, Haryana

I, Virender, Duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

That the time period within which the project shall be completed by promoter is 10/01/2024

8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

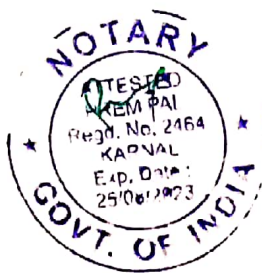
