



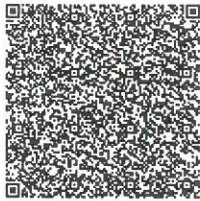

Affidavit cum Declaration of Ms. Namdev Construction Pvt. Ltd. promoter of the proposed project duly authorized by the promoter of the proposed project, vide its authorization dated 07.06.2021 ;

I, Ravi Kant Kumar duly authorized by the promoter of the proposed project M/s Namdev Construction Pvt. Ltd., the Company duly incorporated within the provision of the Companies Act 1956 having its registered office at LGF-10, Vasant Square Mall, Plot-A, Sector-B, Pocket-V, Community Centre, Vasant Kunj, New Delhi-110070, & Corporate office at Suncity Business Tower, Unit No. 224, 2nd floor, sector 54, Golf Coursed Road, Gurugram, do hereby solemnly declare, undertake and state as under:-

1. That Promoter has a legal title to the land on which the development of the project is proposed.

Explanation.—where the promoter is not the owner of the land on which development of project is proposed, details of the consent of the owner(s) of the land along with a copy of the registered (wherever applicable) collaboration agreement, development agreement, joint development agreement or any other agreement, as the case may be, entered into between the promoter and such owner and copies of title and other documents reflecting the title of such owner on the land on which project is proposed to be developed.

9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.





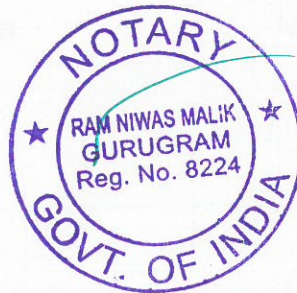
