Subject:- Clarification regarding applicability of Wildlife Laws.

Applicant M/s Namdev Construction Pvt. Ltd. Through their authorized representative Mr. Navneet Kumar, DGM Business Development, vide their letter dated 11.11.2020 made a request for clarification regarding applicability of wildlife Laws for Plotting Purpose situated at **village Gawal Pahari, Tehsil Wazirabad, Distt. Gurugram** bearing having Mustil No. 14 Kila No. 5/2(5-0), 6 (7-8), 14/2(0-9), 15(7-8), 16(7-8), 17(8-0), 24(8-0), Mustil No. 27 Kila No. 4(8-0), 7(8-0), 14/1/3(2-7), 14/1/1(0-1), 15/1(3-13), 16/1/2(1-5), Mustil No. 7 Kila No. 25/1(5-17), 25/2(2-3), 25/3(1-1). Applicant made a proposal to use this land for Plotting project. In continuation of the report submitted by Inspector Wildlife Life, Sultanpur National Park, after making a joint inspection of the area with user agency, vide his letter no. 207 dated 14-01-2021, this site is not falling in Assola Wild Life Sanctuary ESZ area and National Park ESZ area, It is made clear that:

1. Clarification is valid for Applicability of Wildlife Protection Act, (1972) from wildlife angle only, Title Ownership of Land, applicability of provision of other statutory laws such as Environment Protection Act, Indian Forest Act or Forest Conservation Act and any other license conditions are not validated by this clarification.
2. Clarification is valid only if the area which was shown by the user agency for inspection to the Inspector Wild Life Sultanpur National Park and marked by them on survey Sheet of India Sheet No. H43X3 (submitted to this office in project report) is same which the user agency is seeking clarification.
3. User agency will follow all the provisions of wild Life Protection Act, (1972).
4. User agency will follow all the direction of CEC and all the Judgment of Hon'ble Supreme Court of India and other Courts passed from time to time.
5. User agency will take separate clarification/clearance/ permission from competent authority /court regarding Forest Laws, various notification and guidelines issued by Ministry of Environment and Forest under Environment Protection Act, (1986).
6. User agency will take all approval, required under the Environment Protection Act 1986.
7. This office has neither conducted any environment impact assessment nor user agency has submitted any report for the same to this office.
8. User agency will use the area for the same purpose for which clarification is sought i.e. Plotting Purpose.
9. User agency will construct high periphery wall so as to prevent wild animal from entering the compound.


If at any point of time it is found that user agency has suppressed or misrepresented any fact while they submitted their application than or Violation of any condition will attract cancellation of this clarification and will attract penal provision of Wildlife Protection Act, (1972).
