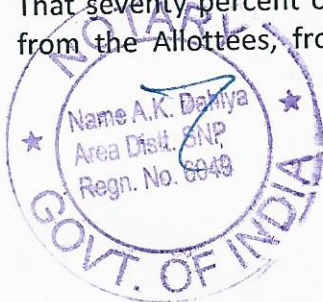

9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
