You are hereby authorized to connect your 150mm dia main sewer line for dispose off sewage water in existing manholes of 1600mm i/d master sewer line along master road between Sec - 10 / 37C, Gurugram . You are requested to connect your sewer connection in the master sewer line under the supervision of concerned Engineer of this office. In addition to the above you are requested to furnish and affidavit that you will have to deposit the monthly sewerage charges on the rates fixed by competent authority from time to time. The sewerage connection is sanctioned on the following terms and conditions:-

1. An amount of Rs. 3,00,000/- (Rs. Three lakh only) has been received in GMDA account on dated 10.11.2020 vide reference No GMDASRWC317381604662952862, transaction id 20110679946321 and File Id SRWC-1603969686146 on account of security charges and sewer connection fee in GMDA, Gurugram
2. If any services or road crossing required at site during the connection with master sewer line, the necessary permission may be obtain from the concerned office
3. M/s Dhoot Infrastructure Project Ltd will deposit the EDC (External Development Charges) as fixed by competent authority
4. Sewer connection will be made in the presence of the GMDA staff & representative of M/s Dhoot Infrastructure Project Ltd (Serenity) and the monthly sewerage charges shall also be paid by the firm regularly
5. The connection shall be maintained strictly as per rules and regulations framed by GMDA.
6. Sewer connection will be utilized for dispose off the treated water as approved in drawings of above site i.e. Commercial Colony Dhoot Infrastructure Project Ltd.in Sector - 37C, Gurugram" an area measuring 16184 sqm, License No. 160 of 2008 falling in Sector No. 37C, Gurugram being developed by M/s Dhoot Infrastructure Project Ltd
7. For any dispute in connection with the release of sewer connection/ maintenance and disconnection, etc. for the said sewer connection and matter shall be referred by any of the two

parties to the concerned Superintending Engineer, GMDA, Gurugram and his decision in the matter shall be final and legally binding on both the parties.

8. Checking of actual assessment of discharge and verification shall be made jointly by the representative of Dept. and colonizer based on discharge of pipes / area.
9. You will not be allowed to dispose sewage water in any other natural drain & FIR may be lodged in case of non - compliances. The case of violation the sewer connection will be summarily cancelled.
10. You may also ensure that follow the guide lines of N.G.T/ HSPCB / CPCB regarding the STP as per Hon'ble Supreme Court
11. The treated sewage from your factory will be discharged into GMDA Master Sewer line and all norms for disposal of waste water shall be fulfilled as fixed by HSPCB/CPCB/NGT Or Any other controlling authority in Gurugram.
