Affidavit cum Declaration

Affidavit cum Declaration of Mr. Rakesh Roshan duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That the Merit Marketing Private Limited, Sunglow Overseas Private Limited, BPTP Limited, Saraswati Kunj Infrastructure Private Limited and Eventual builders Private Limited have a legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the collaboration agreement dated 05.10.2020 vide registration no. 1724 between Merit Marketing Private Limited, Sunglow Overseas Private Limited, BPTP Limited, Saraswati Kunj Infrastructure Private Limited and Eventual builders Private Limited in collaboration with Countrywide Promoters Private Limited for development of the real estate project is enclosed herewith.

- 2. That the said land of 7.03125 Acres is free from all the encumbrances.
- 3. That the time period within which the project shall be completed by the promoter is March 31, 2025.
- 4. That seventy per cent of the amounts realized by promoter or the real estate project from the Allottees, from time to time, shall be deposited in a separate account no 250010210202 opened with IndusInd Bank, Barakhamba Branch, to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.

- 6. That the amounts from the separate account shall be withdrawn the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That the promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
