I, Ravi Kant Kumar duly authorized by the promoter of the proposed project M/s Essel Infra LLP, the LLP duly incorporated under the provision of the Limited Liability Partnership Act 2008 having its registered office at LGF-10 Vasant Square Mall, Plot-A, Sector-B, Pocket-V, Community Centre, Vasant Kunj, New Delhi-110070 & Corporate Office at Suncity Business Tower, 2nd Floor, Sector 54, Golf Course Road, Gurugram , Haryana, do hereby solemnly declare, undertake and state as under:-

1. That Promoter has a legal title to the land on which the development of the project is proposed.
