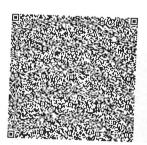

We, Splendor Landbase Ltd. promoter / developer of the above project do hereby solemnly declare, undertake and state as under:

- 1. That the Promoter has legal title to the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances except creation of equitable mortgage on the Said Land and Building to be constructed thereon and receivables in favour of Indiabulls Housing Finance Limited in order to secure the term loan to part finance the construction of the Said Project presently availed by the Promoter from Indiabulls Housing Finance Limited.
