Affidavit cum Declaration of Mr. Suneet Puri duly authorized by the Promoter of the proposed project "Westerlies Phase – 4" vide its authorization letter / board resolution dated 05-07-2017.

I, Suneet Puri duly authorized by the Promoter of the proposed project, do hereby solemnly declare, undertake and state as under:

That SAS Servizio Pvt. Ltd. has the legal title to the land on which the development of the 1. proposed project is to be carried out by the Promoter and a legally valid authentication of

the title of such land along with an authenticated copy of the agreement between such owner and Promoter for development of the real estate project is enclosed herewith.

Explanation:- where the promoter is not the owner of the land on which development of project is proposed, details of the consent of the owner(s) of the land along with a copy of the registered (wherever applicable) collaboration agreement, development agreement, joint

development agreement or any other agreement, as the case may be, entered into between

- the promoter and such owner and copies of title and other documents reflecting the title of such owner on the land on which project is proposed to be developed.
- 2. That SAS Servizio Pvt. Ltd. (Land Owner) and Experion Developers Pvt. Ltd. (Promoter) have executed a registered Supplementary Agreement II dated 04.06.2018, whereby SAS Servizio Pvt. Ltd. has granted the development rights to the Promoter to develop a residential plotted colony on the lands ad-measuring 16.03125 acres situated in Village Dharampur, Tehsil Kadipur & District Gurugram, Haryana ("Project Lands").
- 3. That SAS Servizio Pvt. Ltd. is the sole and exclusive landowner of the Project Lands falling under the proposed project i.e. "Westerlies Phase 4" and no other company/ entity/ person is having any ownership rights in the Project Lands.
- 4. That the said land is free from all encumbrances.

- 5. That the time period within which the project shall be completed by the Promoter is 10.09.2024.
- 6. That seventy per cent of the amounts realized by Promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 7. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the Promoter in proportion to the percentage of completion of the project.
- 8. That the amounts from the separate account shall be withdrawn by the Promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 9. That the Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 10. That the Promoter shall take all the pending approvals on time, from the competent authorities.

- 11. That the Promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 12. That the Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
