- e) All other statutory clearance mandated under the Environment Protection Act, 1986 or any other Act/order shall be obtained as applicable by the project proponents from the concerned authorities-specially in view of the Guidelines contained in Govt. of India's No. 3-11013/41/2006-IA-II (I) dated 02.12.2009.
- f) The project proponent shall ensure that Judicial Orders/ Pronouncements issued by the Hon'ble Supreme Court/High Courts are strictly followed and all necessary clearance in this regard be obtained by them before the start of the execution of the said project.


