I, Akhil Kumar, do hereby solemnly declare, undertake and state as under:

 and promoter for development of the real estate project is enclosed herewith.
- That the said project land of 2.08125 acres is free from all encumbrances.
- That the time period within which the project shall be completed by Company is 31-Mar-2023.
- 4. That 70%(seventy per cent) of the amounts realised by Company for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- 8. That we shall take all the pending approvals on time, from the competent authorities.
- 9. That we have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
- 10. That we shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
