- I, Himanshu Pant, duly authorized by the Ansal Properties & Infrastructure Ltd.(hereinafter referred as "the company" do hereby solemnly declare, undertake and state as under:
- 1. That we have a legal title to the land on which the development of the project is proposed
- 2. That we have a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
- 3. That the said land is free from all encumbrances.
- 4. That the project will be completed by 31.03.2021.
- 5. That seventy per cent of the amounts realized by the company for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

That the company shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 9. That the company shall take all the pending approvals on time, from the competent authorities.
