- I, <u>Akhil Kumar</u>, duly authorized by the promoter of the proposed project, do hereby solemnly declare, undertake and state as under:
- That the Landowners have a legally valid authentication of title of such land of project, the Promoter is having an authenticated copy of the agreement between such landowners and promoter for development of the real estate project is enclosed herewith.

- That we have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
