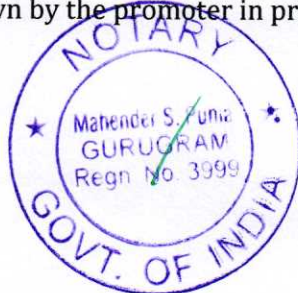

Affidavit cum Declaration

Affidavit cum Declaration of Mr. Dinesh Kumar, Director of the promoter company, duly authorized by the promoter LLP M/s CONMIN INFRADEVELOPERS LLP (Developer) of the proposed real estate project, "PALM COUNTY" on land admeasuring 6.30 acres, situated in Village Shikohpur & Naurangpur, Sector-78, District Gurugram, vide authorization letter dated 28.03.2022;

I, DINESH KUMAR, duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That the M/S CONMIN INFRADEVELOPERS LLP (Land Owner) has a legal title of the aforesaid land on which the development of the project is proposed. The Land Owner itself developing the real estate project on the land;
2. That the project land is mortgaged to the M/s CSL FINANCE LIMITED, the lender, as a term loan facility of Rs.34,50,00,000/- (Thirty Four Crore Fifty Lakh Only) has been availed by the land owner of the project land .
3. That the time period within which the project shall be completed by promoter is 05.03.2027.
4. That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a HDFC BANK LIMITED, A 12 THE SHOPPING MALL DLF QUTUB ENCLAVE PHASE 1 GURGAON HARYANA 122002 to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.

6. That the amounts from the separate account shall be withdrawn the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
