Sector-29 Jhajjar for residential plotted colony under Deen Dayal Jan Awas Yojna 13:125 acres located in village Jaundhi was forwarded along with recommendations by SE(OP) circle Jhajjar. This electrification plan was submitted as per license No.60/2018 valid upto 06.09.2023 issued by DTCP to M/s Vijay Laxmi infrabuild at village Jaundhi Sector-29 Jhajjar which has side their Endst. No. LC-3355/PA(SS)2018/26188-201 dated 11.09.2018.

The load calculations and proposal of electrification plan has been scrutinized & the same has been approved with the revision in ultimate load requirement, size of conductor/ cable and size of distribution T/Fs, as under:-

The Load of 1363.55 KW/1741.20 KVA through proposed 11KV independent feeder with conductor size of 80mm²/ 3Cx70mm² XLPE cable to be fed from T/F T-II, 12.5 MVA, 33/11KV at 33KV S/stn. Sampla at the cost of the developer. Also, the cost of VCB at 33kV S/Stn shall be borne by the developer.

The connection shall be released on single point supply (Option-II) i.e multi point connection through reference meter as per Single Point Supply regulation.

The field officer shall amend the bill of material to include standard rating of the 3. transformer for meeting balance 377.65 KVA load. The developer will install distribution T/Fs of standard quality as per Nigam specification to cater the total load requirement of Township (Max. loading 80%).

Inspection charges as per HERC norms be got deposited from the developer, if the work executed under Self Execution Scheme.

The developer must install /erect whole Electrical Infrastructure as per Nigam's design, drawing & specifications within a period of five years after approval of electrification and hand over the system to the Nigam/ RWA as applicable.

These had norms will be revised / updated every three years in sync with updation of 6. EDC charges and will be made applicable prospectively

The main meter room should be locked and the keys of the meter room should be 7. with some authorized persons and conveniently located near the main gate with free accessibility as per existing instructions of the Nigam.

8. Undertaking well defining the responsibility in the event of breakage of seals on metering distribution panel or the main bus bar enclosures etc. be had in each case

The Firm shall bear the inspection fee of the Chief Electrical Inspector to Government of Haryana for inspection of system. 11
