It is intimated that zoning plan for 2.75 acres licence No. 51 of 2009 dated 27.08.2009 has already been approved by DGTCP (refer drawing No. DTCP-2714 dated 13.07.2010). Now, the applicant company has applied for approval of demarcation plan of additional area for which LOI has been issued vide DGTCP memo No. LC-1611/DS(R)-2011/19684 dated 28.12.2011.

The report received from District Town Planner Gurgaon reveals that the dimensions shown on the demarcation plan have been found correct on the ground. As per dimensions shown on the plan, the total area of the site works out to 0.595 acres against the 0.60 acres shown in LOI. Out of this 0.595 acres, an area measuring 0.349 acres comes under 24 m wide internal circulation road. Hence, net area of the \$3te is 0.246 acres. No HT /IOC pipe line passes over/through the site. The site has been demarcated by wire fencing and concrete pillars. The site is reported to be levelled and vacant.

A copy of the demarcation plan received from DTP(P) Gurgaon is enclosed for further necessary action please.

Town Planner, Gurgaon and found to be correct. The total area of the site as per demarcation comes to 2.771 acres against 2.751 acres for which licence has been granted. Out of this 2.771 acres of land an area measuring 0.33 acres comes under 24 mts wide internal circulation road. A 22 feet wide revenue rasta passes through the site and divides into two parts. There is no H.T./IOC line passes through the site. The site is leveled and vacant.
