Reference to your request, the techinical feasibility has been checked by Xen 'OP' and based on his recommendation it is conveyed that power requirement of your project bearing license No. 93 of 2021 dated 12.11.2021 shall be considered from the nearest 220/33 KV S/Stn. Sec-85 Gurugram at the time of release of load. The voltage level of supply will be at 33 KV level irrespective of load as DHBVN has adopted 33 KV level of distribution in Sec 58-115 and Sec 37C & 37D of Gurugram. The load requirement of this project would be evaluated as per DHBVN norms. However, this assurance is subject to following conditions:-

- 1. Subject to availability of power and infrastructure.
- 2. The necessary charges will be got deposited by you as per Nigam instruction and compliance of all other instructions of Nigam will be ensured as per standing instructions of Nigam / HERC Regulations.
