 - In case of your inability to provide suitable land in accordance with Sales Circular No. D14/2018, your consent to abide by the provisions as contained in the Sales Circular No. D-28/2018 which is available on Official website www.dhbvn.org.in (copy enclosed). This will however be an interim option for the firm under the name of applicant with complete details of FAR to assess Ultimate load.
 - iii. Resolution for Authorized Signatory (Duly Notarized) executed by the Director of the company along with the Directorship (DIN) proof of the executants.
 - iv. Due to non availability of DTCP approved layout with complete details of FAR for the Case ID: LC-4584, this office is not able to assess the ultimate load, As such requested to submit the same.
