- 8. That the promoter company shall take all the pending approvals on time, from the competent authorities.
- 9. That the promoter company have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

10. That the promoter company shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion atc.
