I, **Sudhir Jain**, duly authorized by Board Resolution dated 02 May 2019 of **Model Economic Township Limited**, a Company registered under the Companies Act 1956, having CIN U70109HR2006PLC036416 and PAN AADCR4037Q having its Registered office at 3rd Floor, 77-B, IFFCO Road, Sector-18, Gurugram-122015, Haryana, the licensee for the development of an Industrial colony over an area admeasuring 92.54375 acres falling in the revenue Estate of Village Sodhi, Tehsil Badli, Distt. Jhajjar, as per license number 111 of 2022 dated 10/08/2022 of the proposed project named "**Industrial Colony 92.54375 Acres, Sector-10A**" solemnly declare, undertake and state as under:

1. That promoter has a legal title to the land on which the development of the proposed project is to be carried out as mentioned in the License granted for the project.

That the company shall get the accounts audited within six months after the end of every financial year by a Chartered Accountant in practice, and shall produce a statement of accounts duly certified and signed by Chartered Accountant and it shall be verified that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That the company shall take all the pending approvals on time, from the competent authorities.
9. That we have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That the company shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
